# NCMD JAR Training Workbook

This introductory course is aimed at those who are new to the processes of responding to and reviewing childhood deaths and those who manage and administer these processes. The programme will cover the principles and process of the joint agency response (JAR) for sudden unexpected deaths in childhood (SUDIC) and the principles and functioning of Child Death Overview Panels (CDOPs).

#### **Learning Objectives**

- 1. Participants will be familiar with the national procedures for responding to sudden, unexpected child deaths and the role of different professionals within that response.
- 2. Participants will be able to contribute effectively to the review of child deaths in their locality and will understand how to address the needs of the family.
